# 2<sup>nd</sup> ROUND OF GOVERNMENT SUPPORT MEASURES TO TACKLE THE NEGATIVE IMPACTS OF COVID-19 OUTBURST IN 2022

Following the economic measures that have been enacted in the first half of 2022, and due to the unexpected outbreak of the Covid-19 epidemic in Macau, the Government has recently announced that a new pack of measures comprising the total amount of 10 billion Patacas, will be put into practice soon.

This new round of economic support encompasses a total of 9 measures in 5 different areas:

- 1. Monetary support;
- 2. Employment support;
- 3. Exemption and reduction of taxes and fees;
- 4. Interest rates subsidies; and
- 5. Expansion of the domestic demand.

Given that the implementation of some of these measures will require an amendment to the budget, the Government shall submit a budget amendment proposal as soon as possible, for discussion and approval at the Legislative Assembly.

With respect to the area referred to in Item 5. above, the Government shall create Macau's Consumer Festival, where an award will be given for every MOP\$200.00 in the commercial establishments participating in the Festival, by granting a right to participate in a lucky draw, with a limit of five participations for each consumption.

Credit interest subsidy offered to eligible companies	Up to a maximum amount of MOP\$5,000,000.00, for a period of 2 years, with a maximum annual subsidy rate of 4%.			
Extension of the measure comprising the  "Payment of interest only and suspension of the amortization of principal"	Until 31 December 2023.			
4.2. PROVISIONAL ALLOWANCE PLAN FOR THE TAXI SECTOR				
Holders of taxi licenses or permits are granted an allowance to repair vehicles	6 months allowance in the total amount of MOP\$6,000.00.			
Six months Allowance to taxi drivers for fuel and energy	A monthly amount of MOP\$1,000.00 when the hours of accumulated work per month are higher than 5 hours and less than 25 hours in the first half of 2022, and of MOP\$2,000.00 if the accumulated working hours exceed 25 hours per month.
